I have not worked for 2 1/2 yrs due to the stress of my service and my realisation in April 2015 that i had very likely (i am now absolutely sure) met KSM in Taiz in 1997.

My home address is noted below and i would welcome a visit here or i can attend the US embassy as required. Speaking to you about my visit to Yemen is my priority and i will make myself available as you require.

My name is Daniel Futrell and I am a researcher/investigator working from the Defense Attorneys James Connell and Sterling Thomas. Mr. Connell and Mr. Thomas are the defense attorneys representing Ammar al Baluchi, a detainee in Guantanamo Bay, Cuba, who is facing trial and a possible death sentence concerning the 9/11 attacks in New York City. He is the nephew of Khalid Shaikh Mohammed (KSM) and one of the five 9/11 defendants facing a pending trial down at the Military Commission in Guantanamo Bay. Mr. Nevin represents KSM and we are part of the legal defense team of KSM's nephew, Ammar al Baluchi.

As part of our preparation of defense, we have been examining a wide range information and the research you have done is very interesting to us. We would like the opportunity to have an interview with you and have a discussion on research you have done
